POLICIES, RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMINFICATION AGREEMENT

- 1. I further understand that Pampered Paws Dog Day Care LLC has relied upon my representation that my dog is in good health and has not injured or shown aggression or threatening behavior to any person or dog in admitting my for services at their facility.
- I further understand that Pampered Paws Dog Day Care LLC, their owners, staff, partners and volunteers, will not be liable, financially or otherwise, for injuries to my dog, myself or any property of mine while my dog is participating in services provided by Pampered Paws Dog Day Care LLC. I hereby release Pampered Paws Dog Day Care LLC of any liability of any kind arising from my dog's participation in any and all services provided by Pampered Paws Dog Day Care LLC.
- 3. I further understand and agree that any problems with my dog, behavioral, medical or otherwise will be treated as deemed best by staff of Pampered Paws Dog Day Care LLC in their sole discretion, and in what they view as the best interest of the animal. I understand that I assume full financial responsibility and all liability for any and all expenses involved in regards to the behavior and health of my dog.
- 4. I further understand that there are risks and benefits associated with group socialization of dogs. I agree that the benefits outweigh the risks and that I accept the risk. I desire a socialized environment for my dog while attending services provided by Pampered Paws Dog Day Care LLC and while in their care. I understand that while the socialization and play is closely and carefully monitored by Pampered Paws Dog Day Care LLC staff to prevent injury, it is still possible that during the course of normal play my dog may receive minor nicks and scratches from roughhousing with other dogs. Any injuries to my dog will be pointed out by staff upon pick up.
- 5. I understand by allowing my dog to participate in services offered by Pampered Paws Dog Day Care LLC I hereby agree to allow Pampered Paws Dog Day Care LLC to take photographs or use images of my pet in print form or otherwise for publication and/or promotion.
- 6. I further understand that I am solely responsible, financially or otherwise, for any harm or damage caused by my dog while my dog is attending any services provided by Pampered Paws Dog Day Care LLC.
- 7. I understand that if my dog is staying 5 or more days than an imprint of my credit card will be kept on file and if my dog is staying 7 or more days than I will have to prepay 50% with the balance due upon pick up.
- 8. I understand that if my dog is not picked up on time or by a date specified in a separate agreement. I hereby authorize Pampered Paws Dog Day Care LLC to take whatever action is deemed necessary for the continuing care of my dog. I will pay Pampered Paws Dog Day Care LLC the cost of any such continuing care upon demand by Pampered Paws Dog Day Care LLC. - 9. I understand that Pampered Paws Dog Day Care LLC is not liable for damage to personal property belonging to myself or my dog. I understand that the items brought for overnight stays may be damaged/destroyed.
- 10. My dog is not aggressive, however, if he/she behaves aggressively or displays behaviors deemed unacceptable by Pampered Paws Dog Day Care LLC he/she will be removed from the play group. If Pampered Paws Dog Day Care deems my dog a danger to himself/herself or others, my dog may be asked not to return. Such determination will be made at the sole discretion of Pampered Paws Dog Day Care LLC.
- 11. First and for most the safety and wellbeing of your dog(s) is of the highest importance. Insuring that your dog remains safe and well cared for is our first responsibility and as such we take it very seriously. We do our best to have our dog parents screen for pre-existing health conditions but some factors may be beyond our control. In the event that a medical emergency arises while a dog is at our facility or participating in a service that we provide. It is imperative that we are immediately able to get them medical treatment at the closest available facility. We will call ahead to the veterinary offices in closest proximity geographically to us to insure they can handle the emergency present. Your dog will be rushed to the closest available facility for treatment and you will be notified. We notify the owner after we have secured a medical treatment center for the dog to avoid delays that may be caused by emotion on the part of the owner. Our goal is to get your dog medical attention as quickly as humanly possible, and any distractions may interfere with that process.
- 12. I understand that in the event of a medical emergency that Pampered Paws Dog Day Care LLC at its sole discretion deems to need the immediate attention of a licensed veterinarian. I authorize Pampered Paws Dog Day Care LLC to seek medical attention at the closest available veterinary facility. I further agree that I am financially responsible for any medical treatment my dog(s) receives as a result of a medical emergency while attending services provided by Pampered Paws Dog Day Care LLC.
